## RULES AND REGULATIONS FOR JUNIOR FIREFIGHTERS

1. You must be 16 years of age.
2. You must have your parent's permission to join.
3. There is a 10 member limit.
4. 9pm social curfew on school nights, Sunday nights included.
5. 11pm social curfew on any other nights, weekends and vacations.
6. No calls between midnight and 2:30pm the following day except with the Chief's approval.
7. Permission to leave school for daytime fires and medical will have to come from Parents, for review and approval by Chief.
8. Medical training will be allowed with Parents permission pending Chief's review and approval.
9. Juniors are not allowed in the Fire station without a regular member present, except in the event of a fire.
10. Juniors are not allowed blue lights.
11. Juniors are not allowed to a key to the station.
12. Juniors are not allowed on mutual aid calls. (Except with an officer in his/her car)
13. Only one friend is allowed to visit with a Junior at any time and he/she will be responsible for his/her actions while in the Fire station.
14. Member plates will be given at the Chief's discretion.
15. Caps may be purchased, but no jackets.
16. Full turnout gear will be worn at fires and drills.
17. Ladder climbing at fire calls will be limited to six feet.
18. NO INTERIOR FIREFIGHTING WILL BE ALLOWED.
19. AT ANY INCIDENT, JUNIOR'S WILL REPORT TO THE SERVICE TRUCK AND WAIT FOR ORDERS.
20. Juniors may help on mop up operations, salvage, overhaul, in a safe area under an officer's supervision.
21. Minimum yearly requirement to attend six (6) drills.
22. Juniors may ride in the Rescue Truck, Tower or Hose Tender Cab at the officer's direction and discretion. A seat belt will be worn.

23. Junior's may attend any and all company meetings and Uniform Club meeting, but will have no voting rights.
24. Juniors are not to be in the front cabs of the trucks, nor are they to "touch" the pump panels.
25. Juniors are members of the Danielson Fire Dept. and as such are considered representatives of the Danielson Fire Dept. Any disciplinary action taken at school or situation outside the Dept. in the public eye will be reviewed by the Advisory Committee for possible action.

Juniors will follow the department chain of command. Any problems that cannot be handled by LT. William Gregoire or LT. Ryan Kelleher, being in direct charge of the Junior members, will then be taken to the Chief.
